



# Axos Bank™ Third Party Authorization Form

The undersigned applicant, borrower, or accountholder (collectively, "Customer") hereby authorizes Axos Bank™ and its employees and agents to communicate with, release information to, and receive information from the third-party designated below ("Agent"), including, without limitation, the following kinds of information exchanges:

1. Discuss and negotiate Customer's Axos Bank account, loan, application, or other Axos Bank-related matter (collectively, "Customer's Business");
2. share, release, discuss, and otherwise provide non-public personal information contained in or related to Customer's Business, including, without limitation, information that otherwise would be confidential and not disclosable to Agent but for Customer's execution of this Third Party Authorization Form (the "Authorization");
3. request, receive, and review information from Customer's Agent that in Bofl's reasonable judgment is related to the Customer's Business; and
4. receive and review any information from Customer's Agent that Agent discloses to Axos Bank irrespective of whether Axos Bank has requested the information.

Customer further understands, acknowledges, and agrees to the following:

2. This Authorization is being made at Customer's request, as an accommodation to Customer (it being understood that Axos Bank would not communicate with Customer's Agent but for Customer's execution of this Authorization);
3. Any information Bofl receives from Customer's Agent may be reviewed by Axos Bank and used, subject to any requirements of applicable law, in any Axos Bank application or Axos Bank account/loan servicing process related to Customer;
4. Information regarding the Customer and Customer's Business (including any property related to a loan/application) may be released to Customer's Agent, per the terms of this Authorization, and with respect to such release to Customer's Agent only, Customer waives any right to confidentiality of that information that may exist;
5. Axos Bank shall not be liable to Customer or any person claiming by or through Customer for releasing, receiving, reviewing, or relying on, in each case, information pursuant to the terms of this Authorization; and
6. Customer represents and warrants to Axos Bank that Customer is sufficiently familiar with Customer's Agent (including, without limitation, Agent's practices and policies for handling any information communicated pursuant to this Authorization) and accepts responsibility for any act or omission of Customer's Agent with respect to communication between Axos Bank and Customer's Agent contemplated by this Authorization.
